RE: Update Regarding Construction at the Donlands Subway Station

Dear Parents/Families,

I hope my letter finds you and your family well.

I would like to provide an update to the construction that is currently taking place at the Donlands Subway Station.

1. Schedule for Construction

Starting on Monday May 10th, 2021, the TTC will be expanding the work zones at the northwest and southwest corners of Strathmore Boulevard and Donlands Avenue for the construction of the elevator to the concourse level of the subway station.

With these expanded work zones, the Donlands Station bus loop will be closed and buses will not enter the station.

We have attached a notice from the TTC regarding this stage of the construction to this correspondence for your review. This notice has further details on the work being completed and the changes to the bus service.

The TTC has confirmed that access to the Child Care Centre will be maintained at all times throughout this construction, and that noisy work will be performed no earlier than 3:00 pm.



2. Health and Safety

I would like to review the Health and Safety Precautions that both Network Child Care Services (Network) and the TTC will be taking to mitigate the effects of the construction at the subway station.

Network has placed three portable air purifiers in the playrooms to collect any dust from the construction. The air purifier model is the *Austin Air HM 400 Standard HealthMate unit*, and a flyer with further information regarding this device has been attached with this correspondence.

Major works involving larger amounts of noise, including drilling and excavation, will take place no earlier than 3:00 pm.

The TTC confirms that this project has been worked on by skilled engineers. The contractor will install noise and vibration monitors at the site, which will be reviewed daily.

The TTC has also constructed mesh fencing and hoarding throughout the construction site and will complete a watering of the street on a scheduled basis to mitigate the dust.

3. Communication with the TTC

Network will maintain an open communication with parents and families throughout the construction process. Alongside this, Network will remain in close communication with the TTC for any updates in the work.
