## MEMORANDUM

**RE: Update Regarding the Metamorphosis Child Care Centre**

Dear Parents/Families,

Further to my correspondence on July 19<sup>th</sup>, 2021, I would like to provide you with an update regarding the temporary relocation of the Metamorphosis Child Care Centre and the Engineers' investigation.

At this time, we are able to convey the following information:

1. The heavy-duty excavation and drilling, at the former playground, have been scheduled to take place over a period of six weeks. There is one more week left to complete this activity. The TTC and its Contractor will try to complete this work during the week of August 23<sup>rd</sup>, 2021.
2. The review concerning the daily vibration data indicates that the vibration activity was within the permitted parameters. The TTC has advised that they will add an additional vibration monitor within the Child Care Centre.
3. As you are aware, on July 11<sup>th</sup>, 2021, an incident occurred at the Metamorphosis Church where a piece of plaster from the ceiling had fallen and a few cracks on the wall were noticed. This may be related to the TTC's work.

Since then, the matter is being investigated by both the TTC and Independent Structural Engineers.

To date, we have not identified any damages of concern to the child care premises.



4. Today, Thursday, August 19<sup>th</sup>, 2021, the TTC's third party Engineering Consultant has advised that they will be submitting their report, to all parties, by end of the day on Friday.
5. The TTC has scheduled a follow-up meeting, with all parties, on Saturday, August 21<sup>st</sup>, 2021, to discuss their findings and next steps. After this meeting, we will provide an update with any new information or developments.
6. I confirm that our Lease Agreement which we have signed with the TDSB to occupy the three classrooms and the gymnasium at the Wilkinson Junior Public School is until Friday, August 27<sup>th</sup>, 2021, inclusive. We are in communication with the TDSB to potentially secure alternate space if we won't be able to return to our premise on August 30<sup>th</sup>, 2021.

Once again, we apologize for the inconvenience that this has caused. We appreciate that this uncertainty is very stressful for all involved. However, we will provide an update at the beginning of next week once all of the details have been made available to us.
